The Management Body should have at its disposal proven capabilities in, *inter alia*, basic computer skills, financial management, written communication and operational security matters (to back-up existing expertise); and the Directors should be prepared to contribute, spend time and perform agreed functions to ensure the effective and successful operation of this Company.

Currently five (5) of the full complement of seven (7) Directors on the Management Body of HPP are occupied. This year three of the directors are due for retirement on rotation. The portfolios that become vacant are Cleaning Operations, Security Operations and Public Relations/Communications. Councilor Kari Brice serves on the board as the nominated director of the Overstrand Municipality.

Should you wish to nominate a person for these vacancies, then please note that the nominee **must** accept his/her nomination in writing and that you attach his/her CV to the nomination. To indicate reasonable support for such a nomination, it is suggested that the nomination be signed by five (5) Members.
