ROUND ROBIN RESOLUTION OF THE DIRECTORS OF HERMANUS PUBLIC PROTECTION (HPP) NPC

1. BACKGROUND:

- 1.1 Infrastructure upgrade: following the independent assessment of the camera network operations of HPP, a number of recommendations were accepted to improve the efficiency of the system. The improvements included upgrading computers, analytics software licenses, reporting software and IT equipment to improve efficiencies and future proof the IT operations system.
- 1.2 Incident Command Centre (ICC): as planned for in the HSRA business plan the HPP will relocate to a joint operations ICC hosted by the Overstrand Muncipality. HPP's investment into the ICC aims to create a joint response from all law enforcement stakeholders and the contribution to install the fixtures and fittings will form part of the free lease agreement arrangement.
- 1.3 CBD Initiatives: to further supplement and upgrade the HSRA in the Overstrand Municipality, HPP will contribute to the beatification and enhancement of the CBD of Hermanus.
- 1.4 Safety Kiosk: to improve perceptions of safety across the HSRA, a visible safety kiosk with camera technology will enhance the public safety service currently offered.
- 1.5 Homelessness Initiative: in order to address an increasing issue in the area, HPP will fund various initiatives in support of the Overstrand Municipality, NGO's, churches and other stakeholders. A limited fund is being available for this purpose.

2. RESOLVED:

- 2.1 THAT: Costs associated with the Infrastructure upgrades amounting to a total estimate of R400,000 is hereby approved and shall be allocated.
- 2.2 THAT: Costs associated with the installation of fixtures and fittings for the ICC amounting to a total estimate of R300,000 is hereby approved and shall be allocated.
- 2.3 THAT: Costs associated with the CBD initiatives as outlined amounting to the a total estimate of R45,000 is hereby approved and shall be allocated.
- 2.4 THAT: Costs associated with the Safety Kiosk amounting to a total estimate of R110,000 is hereby approved and shall be allocated.
- 2.5 THAT: Costs associated with the homelessness initiative amounting to no more than R100,000 is hereby approved and shall be allocated.
